I. PRIVACY AND DATA PROTECTION POLICY

- Storage limitation
- Integrity and confidentiality
- Proactive accountability

Categories of personal data

Only identifying data is processed. No special categories of personal data are involved.

Legal basis

The legal basis for processing is the User's explicit and verifiable consent. The User may withdraw consent at any time, which will not affect the lawful use of the Website.

Purpose of processing

To fulfill relationships established via the Website, respond to inquiries, and for commercial, statistical, and service improvement purposes.

Data retention

Data will be kept for no longer than one year, or until the User requests its deletion.

Recipients

Data will not be shared with third parties. If applicable, Users will be informed.

Minors' data

Only users aged 14 and above may consent legally. Parental consent is required for younger users.

Security

Data is handled securely using appropriate technology and a valid SSL certificate. In case of data breaches, Users will be promptly informed.

User rights

Users may exercise rights of:

- Access
- Rectification
- Erasure (right to be forgotten)
- Restriction of processing
- Data portability
- Objection
- Not being subject to automated decision-making, including profiling
